1.2. Assign a qualified specialist for direct management of manufacturing practice of students.

1.3. Create necessary conditions for the accomplishment of practical training programs by students. Prevent their work on position and jobs that do not comply with program of the practical training and future specialty.

1.6. Provide records of work attendance of students. Inform higher education institution of all violations of labor discipline, internal regulations and other violations.

1.8. Give the students opportunity to collect information for course projects and diploma which based on the results of the company activity, which is not a commercial secret based on referrals from the Departments.

**2. Higher educational institution commits itself to:**

2.1. Before the beginning of practical training submit to the practical training base of program practical training for confirmation, and no later than one week before – a list of students who are sent to the practical training.

2.2. Appoint qualified lecturers as heads of practical training.

2.3. Ensure observation of work discipline and internal regulations by students. Participate of the accidents by commission from practical training base if they took place during practical training.

2.4. Higher education institution shall not disclose the information about the company through destruction of course projects diploma and reports according to established procedure.
